

RESOLUTION NO. 21-10

A JOINT RESOLUTION BY THE COMMISSIONERS OF LAURENS COUNTY, GEORGIA AND BY THE MAYOR AND COUNCIL OF THE CITY OF DUBLIN, GEORGIA TO APPROVE AND ACCEPT THE TERMS OF AN INTERGOVERNMENTAL AGREEMENT WITH EACH OTHER FOR THE PROVISION OF CERTAIN SANITARY SEWER SERVICES AND TREATMENT; TO AUTHORIZE THE DESIGNATED REPRESENTATIVES OF EACH GOVERNING BODY TO EXECUTE AND DELIVER THE SAME; TO SET AN EFFECTIVE DATE; AND FOR OTHER LAWFUL PURPOSES.

WHEREAS, Laurens County, (the "County"), has constructed that certain lift station and sewer main which is intended to service West Fraser, Inc., and

WHEREAS, the City of Dublin, ("City"), currently operates a sanitary sewer collection and treatment utility; and

WHEREAS, counties and municipalities are authorized to enter into intergovernmental contracts for the joint provision of services which they are empowered to perform for periods of up to fifty years; and

WHEREAS, the County and the City have specified the terms of their agreement for the services to be provided within the intergovernmental agreement attached hereto as Exhibit A and incorporated herein by this reference.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNMENTS OF LAURENS COUNTY, GEORGIA and the CITY OF DUBLIN, GEORGIA do hereby adopt and approve the terms of the Intergovernmental Agreement attached hereto and agree to bind their respective governments to the terms thereto.

BE IT FURTHER RESOLVED that, as to Laurens County, the county administrator and the chair of the commission are authorized to execute and deliver the same on behalf of Laurens County; and

BE IT FURTHER RESOLVED that, as to the City of Dublin, the Mayor and City Clerk are authorized to execute and deliver the same on behalf of the City of Dublin; and

BE IT FURTHER RESOLVED that this Resolution shall be effective as to each government on the date upon which it is approved by the respective governing body in an open and public meeting.




