1. **DATE OF ELECTION:** *Tuesday, November 2, 2021*
2. **QUALIFYING DATES:**
  - Begins: *Monday, August 16, 2021 - 8:30 A.M.*
  - Ends: *Friday, August 20, 2021 - 4:30 P.M.*
3. **LAST DAY TO REGISTER TO VOTE:** *Monday, October 4, 2021*
4. **OFFICE TO BE FILLED:**
  - COUNCIL MEMBERS AT LARGE (3)
  - SCHOOL BOARD MEMBERS for SUPER DISTRICTS 1, 2, & AT LARGE (1)
5. **QUALIFYING FEE:**
  - Council Member \$ 252.00
  - School Board Member \$ 108.00
6. **QUALIFICATIONS for COUNCIL MEMBERS AT LARGE (3):**
  - a. Must be a registered and qualified voter of the City of Dublin at the time of qualifying for office.
  - b. Must be a resident of the City of Dublin at the time of qualifying for office and must continue to reside therein during the term of office.
  - c. All Council Members must be at least twenty-one years of age.
7. **QUALIFICATIONS for SCHOOL BOARD MEMBERS for SUPER DISTRICTS 1, 2, & AT LARGE (1):**
  - a. SUPER DISTRICT 1-Must be a registered and qualified voter of the City of Dublin at the time of qualifying for office and must have resided in Education Super District 1 for at least six months immediately prior to qualifying for election and continue to reside therein during the term of office.
  - b. SUPER DISTRICT 2-Must be a registered and qualified voter of the City of Dublin at the time of qualifying for office and must have resided in Education Super District 2 for at least six months immediately prior to qualifying for election and continue to reside therein during the term of office.
  - c. AT LARGE-Must be a registered and qualified voter of the City of Dublin at the time of qualifying for office and must have resided within the city limits of Dublin for at least six months immediately prior to qualifying for election and continue to reside therein during the term of office.
  - d. All School Board candidates must possess a high school diploma or its equivalency.
  - e. All School Board candidates must be at least twenty-one years of age.
8. **VOTERS LIST:** Available at Registrar’s Office, Laurens County Courthouse for a fee.
9. **LOCATION OF ELECTION** Stubbs Park Gym on Calhoun Street
