

RESOLUTION

A RESOLUTION BY THE MAYOR AND COUNCIL OF THE CITY OF DUBLIN TO AUTHORIZE THE PARKS COMMITTEE TO HAVE APPROVAL OF ALL CONTRACTS WITH LANDSCAPE ARCHITECTS, ENGINEERS, AND THE ENGAGEMENT OF CONTRACTORS IN REGARD TO IMPROVEMENTS OF SPRINGDALE PARK; TO AUTHORIZE THE MAYOR TO EXECUTE AND DELIVER THE SAME; TO PROVIDE FOR AN EFFECTIVE DATE; AND FOR OTHER LAWFUL PURPOSES.

WHEREAS, the Parks Committee has requested from the City the authority to approve contracts with landscape architects, engineers, and the engagement of a contractors in order to efficiently execute the improvements to Springdale Park, (the "Project"); and

WHEREAS, such authority would allow the Parks Committee to approve a contract with 1) A landscape architect; 2) Engineering Firm for the necessary Civil Engineering Services; and 3) a Construction Contractor as to their fees and preliminary design and drafting costs so that all three can work together simultaneously to provide the greatest amount of collaboration on finalizing the project; and

WHEREAS, the City Council would hold final approval of a Guaranteed Maximum Price or final construction pricing for the construction work of the project; and

WHEREAS, the Mayor and Council find it in the best interest of the city to approve the request of the Parks Committee in regard to contracting for the fees of each of the services outlined above for the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL that upon approval and recommendation by the Parks Committee of Council, the City Manager, and the approval of the City/Staff Attorney as to its form, the Mayor is authorized to execute and deliver an agreement satisfactory to them as may be appropriate for the performance of the Project, except that any final pricing for the construction of the project must be presented to the City Council for final approval.

BE IT FURTHER RESOLVED that all actions of the City, its officers, and staff in connection with the execution, delivery, and performance of the Project and the purposes of this Resolution are hereby approved, ratified, and confirmed. Upon recommendation of the City Manager and the City/Staff Attorney, the Mayor is further authorized to execute any other document in furtherance of the purposes of this Resolution.

BE IT FURTHER RESOLVED that the City Manager may approve such modifications, change orders, or reduction or addition of services to the contract awarded herein as they may relate to design and plan drafting services as may be deemed appropriate and necessary by him and the mayor may execute and deliver the same upon said recommendation and approval by the City Manager. In no event may the city manager be authorized to approve a change order for the final construction costs or guaranteed maximum pricing for the project without first obtaining council approval.

BE IT FURTHER RESOLVED that this Resolution shall have immediate effect upon its adoption.
