A RESOLUTION BY THE MAYOR AND COUNCIL OF THE CITY OF DUBLIN, GEORGIA TO ACCEPT AND APPROVE THE TERMS OF A MEMORANDUM OF UNDERSTANDING WITH OCONEE FALL LINE TECHNICAL COLLEGE TO PROVIDE ADULT EDUCATIONAL RESOURCES AT THE LOCATION OF 511 CHARLES MANNING SR WAY, DUBLIN, GEORGIA; TO AUTHORIZE THE MAYOR TO EXECUTE THE SAME; TO SET AN EFFECTIVE DATE; AND FOR OTHER LAWFUL PURPOSES.

WHEREAS, Oconee Fall Line Technical College ("OFTC") is a unit of the Technical College System of Georgia that provides educational services in Dublin and Laurens County and desires to provide those services to the citizens of Dublin, Georgia at centralized locations; and

**WHEREAS**, the City of Dublin desires to provide access to educational services and resources offered by OFTC to its citizens; and

**WHEREAS**, the City of Dublin desires to enter into agreements to provide these services and resources through OFTC as it will be in the interest of public health, safety and welfare; and

**WHEREAS**, a proposed draft of the Memorandum of Understanding for Fiscal Year 2025 and Fiscal Year 2026 has been attached hereto as Exhibits "A" and "B".

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF DUBLIN and it is hereby so resolved by the authority of the same, that that the terms of terms of the Memorandum of Understanding for Fiscal Year 2025 and Fiscal Year 2026 attached hereto are approved, and that the Mayor is authorized to execute memorandum of understanding in substantially the same form as attached hereto as Exhibits "A" and "B";

**BE IT FURTHER RESOLVED** that the Mayor and Council of the City of Dublin grant authority to the City Manager to take any and all further actions necessary to carry out the intents and purposes of this Resolution, including, but not limited to, approving any necessary amendments and renewals to said Memorandum of Understandings, as deemed appropriate by the City Manager, so long as no additional appropriations are required to be approved by Mayor and Council. Any such amendments or renewals may be executed by the Mayor upon the approval of the City Manager;

**BE IT FURTHER RESOLVED** that the Mayor and Council of the City of hereby declare the foregoing preamble and whereas provisions set forth hereinabove constitute, and shall be considered to be, substantive portions of the Resolution and are hereby incorporated by reference into this provision;

**BE IT FURTHER RESOLVED** that in the event scrivener's error shall be discovered in this Resolution or in the Exhibits hereto after the adoption hereof, the Mayor and Council hereby authorized and direct that each such scrivener's error shall be corrected in all multiple counterparts of this Resolution; and

**BE IT FURTHER RESOLVED** that this resolution shall have immediate effect upon its adoption.
