## RESOLUTION #25-36

A RESOLUTION BY THE MAYOR AND COUNCIL OF THE CITY OF DUBLIN, GEORGIA TO ACCEPT AND APPROVE THE TERMS OF AN INTERGOVERNMENTAL AGREEMENT WITH LAURENS COUNTY, GEORGIA FOR OWNERSHIP, CONTROL, CARE AND MAINTENANCE OF RIGHT OF WAY ON THE PINEHILL ROAD SPUR, DUBLIN, GEORGIA; TO AUTHORIZE THE MAYOR TO EXECUTE THE SAME; TO SET AN EFFECTIVE DATE; AND FOR OTHER LAWFUL PURPOSES.

WHEREAS, the City of Dublin received a request to annex property located at 630 Pinehill Road, Laurens County, Georgia, Map & Parcel 129 024; and

WHEREAS, O.C.G.A. § 36-36-7 (c): Whenever a municipality annexes land on both sides of a county road right of way, the annexing municipality shall assume the ownership, control, care, and maintenance of such right of way unless the municipality and the county agree otherwise by joint resolution; and

**WHEREAS,** pursuant to O.C.G.A. § 36-36-4 (a): The creation of unincorporated islands as described in paragraph (1), (2), or (3) of this subsection shall be prohibited: (1) Annexation or deannexation which would result in the creation of an unincorporated area with its aggregate external boundaries abutting the annexing municipality...; and

WHEREAS, the City of Dublin desires to annex said property and not create an unincorporated island out of the neighboring property; and

WHEREAS, a draft of the Intergovernmental Agreement for the ownership, control, care, and maintenance of right of way on the Pinehill Road Spur has been attached hereto as Exhibit "A."

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF DUBLIN that that the terms of terms of the Intergovernmental Agreement for the ownership, control, care, and maintenance of right of way on the Pinehill Road Spur attached hereto are approved, and that the Mayor is authorized to execute the agreement in substantially the same form as attached hereto as Exhibits "A";

**BE IT FURTHER RESOLVED** that the Mayor and Council of the City of Dublin grant authority to the City Manager to take any and all further actions necessary to carry out the intent and purpose of this Resolution, including, but not limited to, approving any necessary amendments, renewals, and terminations to said Agreement, as deemed appropriate by the City Manager. Any such amendments, renewals, and terminations may be executed by the Mayor upon the approval of the City Manager;
